

EXPRESSION OF INTEREST (including Pre-Qualification Requirements)

Supply of Open Hole Gravel Pack (OHGP) & Associated Services

Overview:

- Hibernia Management and Development Company Ltd. (HMDC) & ExxonMobil Canada Properties, a partnership (ExxonMobil) are in the process of pre-qualifying companies who can supply an Open Hole Gravel Pack (OHGP) & Associated Services for their offshore Newfoundland and Labrador requirements.
- Contractor shall provide all management, personnel, processes, materials, tools, equipment, applicable certifications and facilities as may be required to ensure all equipment covered by this pending Contract shall be fabricated and supplied to meet all statutory requirements, codes of practice and applicable specifications.
- The intention is to have this scope of work cover the requirements of the Hibernia Project* and the Hebron Project. For clarity, the scope of work includes not only the foregoing, but all future work in which ExxonMobil or HMDC may engage onshore or offshore Newfoundland and Labrador, including but not limited to seismic, drilling, development and operations.
- While not planned, it should be noted that the resulting contract may require inclusion of and/or extension to other operators in the area, project co-venturers, contractors and/or affiliated companies.
- For work related to the Hibernia Project*, HMDC supports providing opportunities to Canadian, and, in particular, Newfoundland and Labrador companies and individuals, on a commercially competitive basis. Contractors expressing interest in providing services or materials, if they are selected to bid, will be required to complete a Canada-Newfoundland and Labrador Benefits Questionnaire at the bid stage.
- For work related to the Hebron Project, ExxonMobil supports providing opportunities to Canadian, and, in particular, Newfoundland and Labrador companies and individuals, on a commercially competitive basis. Contractors expressing interest in providing services or materials, if they are selected to bid, will be required to complete a Canada-Newfoundland and Labrador Benefits Questionnaire at the bid stage.
- Hibernia Management and Development Company Ltd. (HMDC) & ExxonMobil Canada Properties, a partnership (ExxonMobil) encourages the participation of members of designated groups (women; Aboriginal peoples; persons with disabilities; and members of visible minorities) and corporations or cooperatives owned by them, in the supply of goods and services.

Scope of Work Overview:

The scope of work/supply includes but is not limited to:

Provision of Gravel Pack Equipment (Temporary), Materials, and Services for the purposes of executing gravel pack operations for ExxonMobil & HMDC at various site locations offshore Newfoundland.

Work shall include:

(1) Hebron Platform: Supply of all materials including but not limited to fluids, proppant, chemicals, personnel, engineering services etc., excluding equipment previously awarded.

(2) Hibernia Platform: Supply of all materials including but not limited to all required equipment (pumping units, silos, augers etc.), fluids, proppant, chemicals, personnel, engineering services, etc.

(3) Hebron MODU Operations: Supply of all materials including but not limited to all required equipment (pumping units, silos, augers etc.), fluids, proppant, chemicals, personnel, engineering services, etc.

The three scopes of work may be awarded to a single vendor. However, each scope of work may be awarded in part pursuant to further evaluation.

Additionally, the selected contractor will be required to meet all technical and Safety, Health, Environmental, and Security (SHE&S) specifications and safe work practices of ExxonMobil & HMDC and their affiliates as appropriate.

Minimum Technical Requirements

Not required at this time.

Submission Requirements

Vendor submissions in response to this Expression of Interest (including pre-qualification) **must** include the afore-mentioned reference number as well as the following information:

1. Information demonstrating qualification for the Scope of Work detailed above.
2. Describe your experience operating under and familiarity with, the benefits provisions of the [Canada-Newfoundland and Labrador Atlantic Accord Implementation Acts](#) and your experience with any similar regimes in other parts of Canada or internationally. At the RFP/ITT stage, bidders will be required to indicate how they comply with the above.
3. Please acknowledge that responsible management personnel have read, understand and will support requirements to comply with the following
 - i) Section 45 of the Canada-Newfoundland and Labrador Atlantic Accord Implementation Acts
 - ii) The Hebron Benefits Agreement work requirements

The data submitted in response to the aforementioned questionnaires will be used to evaluate your company's ability (and those of your preferred sub-contractors / vendors where applicable) to perform these services or provide these materials. [Additional questionnaires and evaluation should be anticipated in advance of ExxonMobil/HMDC finalizing a bidders list.](#)

This Expression of Interest (including pre-qualification) is not a pre-qualification of contractors for other [ExxonMobil /HMDC work but is limited to the scope aforementioned.](#) In addition, participation in this Expression of Interest (including pre-qualification), including any statements whether oral or written between [ExxonMobil / HMDC](#) and your company shall not create or be deemed to create any binding legal relationship or contract, or be construed to do so between [ExxonMobil / HMDC](#) and your company. All costs associated with the preparation of your response to this expression of interest shall be at your expense.

Finally, it should be clearly understood that this Expression of Interest (including pre-qualification) may or may not result in the issuance of an RFP/ITT and may or may not result in the award of a contract. Further, it should be clearly understood that if you respond to this Expression of Interest (including pre-qualification) and your company is selected to be on the bidders list that your company name and contact information may be posted on public websites. Similarly, if you are selected for award, the same information may also be posted indicating that the work has been awarded to your company.

* It should be assumed that the Hibernia Project includes but is not limited to current and planned Hibernia and Hibernia Southern Extension operations as well as future development on behalf of Hibernia (operated by Hibernia Management and Development Company Ltd.) and/or Hibernia Southern Extension participants (operated by ExxonMobil Canada Properties).
